Subject: POLICE AND MAGISTRACY - COOPERATION


In order to achieve maximum cooperation between the Police and the Magistracy, the following instructions are laid down for the guidance of the Superintendents of Police.

1. The executive function of maintenance of law and order consists of 2 parts - Magisterial and the Police. The respective spheres of responsibility have been detailed in the Cr.P.C. and the Police Act 1861. The utmost harmony, coordination and cooperation of the two aspects of the function alone can secure the maintenance of public peace in the district. The maintenance of personal contact by meetings, consultations and joint tours where-ever possible between the District Magistrate and the Superintendent of Police will contribute most to the fulfilment of their joint function of preserving law and order.
2. The District Magistrate may require from the Superintendent of Police, reports either particular or general on any matter connected with the incidence of crimes, habitual offenders, the prevention of dis-order, the regulation of assemblies and processions, the conduct of any police officer subordinate to the Superintendent of Police in the discharge of his duties and all other matters relevant to his functions towards the maintenance of order.
3. In the matter of transfers of Station House Officers, if the District Magistrate observes in any Sub-Inspector In-charge of a Police Station marked incompetence or unfitness for the locality in which he is stationed, he may after consulting the Supdt. of Police, request the latter to transfer him. In case the Supdt. of Police, disagrees with the District Magistrate the matter should be referred to the Deputy Inspector General of Police, Range.
4. The transfer of a Sub-Inspector In-charge of a Police Station by the Superintendent of Police should be done in consultation and in agreement with the District Magistrate without ofcourse entering into any formal correspondence and a note thereof should be made in the transfer order file.
5. In the case of transfers made at the instance of higher authorities, it will be advisable for the Supdt. of Police to keep the District Magistrate informed of the same.
6. If transfer of an Inspector In-charge of a Police is desired by the District Magistrate, the matter should be brought to the notice of the Deputy Inspector-General of Police by the Superintendent of Police.

7. Sub Divisional and other Executive Magistrates are held strictly responsible under the control of the District Magistrates for the maintenance of peace of the area which is made over to their charge. The maintenance of law and order and enforcement of preventive measures depend upon the joint efforts of the public, the Executive Magistrates and the Police and not upon the energy of any one of these alone. Cordial relations and full cooperation between the Police and the Executive Magistrates are essential. Superintendents of Police should take necessary measures to ensure such cooperation.

8. Gazetted Officers and other Police Officers of and above the rank of Assistant Sub-Inspector should develop and maintain good and amicable relations with the Executive Magistrates with whom their work brings them in contact, with a view to keep them in touch with the law and order position of their illaqa. The Superintendent of Police should request the District Magistrate to arrange occasional meetings between the Executive Magistrates and Gazetted Police Officers at which difficulties from either side can be discussed and remedies devised.
