:: Notification ::

In exercise of the powers conferred by section 59 of the Prisons Act, 1894 (Central Act No. 9 of 1894) as adopted to Rajasthan and all other powers enabling it in that behalf, the State Government hereby makes the following rules further to amend the Rajasthan Prisons Rules, 1951, namely:-

1. **Short title and commencement.** - These rules may be called the Rajasthan Prisons (Amendment) Rules, 2010.

(2) They shall come in to force from the date of their publication in the Official Gazette.

2. **Amendment of rule 38 of PART XXII.**- In rule 38 of PART XXII of the Rajasthan Prisons Rules, 1951, here in after referred to as the said rules,-

(i) the existing provision shall be numbered as sub-rule (1).

(ii) after sub-rule (1), so numbered, the following new sub-rule (2) shall be added, namely:-

"(2) Before granting permission to any person for interview, the Superintendent shall satisfy himself about the relationship with the prisoner and identity of such person, who wants to interview the prisoner.

Explanation: The ration card, voter ID card or a certificate from Sarpanch, Tehsildar, or other authorities competent to issue such certificate, shall be sufficient proof of address and relationship."

3. **Amendment of rule 2 of PART XXV.**- After the existing sub-rule (8) of rule 2 of PART XXV of the said rules, the following new sub-rule (9) shall be added, namely :-

"(9) Photograph and finger prints of every prisoner shall be taken at the time of admission."
